1975 Program of Field Trips

Only series subscribers to the Speakers Program may purchase tickets for the Field Trips, which are conducted on a Tuesday or a Wednesday schedule the week following each discussion. A tour ticket is valid only on the date for which the ticket is issued, and must be presented for admission. *There are no refunds on field trip tickets, and no replacement of lost tickets can be made.* The price of each tour is \$9.00. Luncheon (gratuity included) is provided on all tours. Tours depart from and return to the Clinton

Street (west) Entrance to the Chicago & North Western Station (except Tour Two, see below). Tours operate on closely coordinated schedules, and the departure of buses cannot be delayed for late-comers. Comfortable shoes are recommended. Since program arrangements must be made many months in advance, scheduled events may sometimes be subject to change. *Please read carefully the instructions on How to Order Tickets.*

Tour One Tuesday, Sept. 16 • Wednesday, Sept. 17

Depart promptly at 9:00 a.m. for the Criminal Courts Building at 26th and California. Welcome and orientation in the court of the Presiding Judge. Visit the Jury Room and courts in session. Tour three of the adjacent jails, having lunch in one of them and meeting the Executive Director of the Cook County Depart-

ment of Corrections, Winston Moore. Buses return to Northwestern Station at 3:30 p.m. (WARNING: Be prepared for security checks. Purses may be searched or impounded; do not bring metal objects, spray cans, or anything other than items essential for personal use that day.)

Tour Two Tuesday, Sept. 31 • Wednesday, Oct. 1

Meet in City Council Chambers at City Hall, 121 N. La Salle St., promptly at 8:50 a.m. for a film on major services provided by the City of Chicago. Take a behind the scenes tour of City Hall where we'll learn about physical and environmental planning, public health services department, and fire and ambulance dispatch nerve center. Lunch at the Bismarck Hotel at 11:45 (walk ½ block west from City Hall on Randolph St.). Buses leave Bismarck at 12:45 for the

Garfield Parent-Child Center, which is one of 13 Experimental Centers in the country enrolling mothers and their children from infancy to age 5. After a tour of this interesting facility, we will visit the Garfield Community Services Center, which is one of 12 "Urban Progress Centers" operated by the City of Chicago. Buses will return to the Northwestern Station at approximately 3:15 p.m.

Tour Three Tuesday, Oct. 14 • Wednesday, Oct. 15

Depart promptly at 9:00 a.m. for the Museum of Contemporary Art, 237 E. Ontario. There we will follow the route a work of art would take, from the loading dock to the gallery floor, where we will be welcomed by Steve Prokopov, Director, and Ira Licht, Curator. Proceed to Columbia College, 540 N. Lake Shore Dr., where we will be met on the Sound Stage by Jack Wolfson, Director of Development, and department heads who will explain the arts of film, print-making, and other crafts. Visit the school's new art gallery and

its laboratories. Lunch at Arnie's, 1030 N. State. Mr. and Mrs. Arnold Morton, the owners, will tell us about their eclectic collection of furnishings. The afternoon program will be a visit to the Ruth Page Dance Foundation, 1016 N. Dearborn, home of The Chicago Ballet. Ruth Page will greet us and present a lecture-demonstration of dance in the school's intimate performing center. Tour ends at approximately 3:16 p.m.

Tour Four Tuesday, Oct. 28 • Wednesday, Oct. 29

Depart promptly at 8:45 a.m. for the Chicago Educational Television Station (WTTW), 5400 N. St. Louis, to see Northwestern University students training to be newscasters. Proceed by bus to the Merchandise Mart to watch Channel Five put the noon news show together. Lunch at the Merchants and Manufacturers Club, where Jorie Lueloff, Commentator, and Ed

Planer, News Director, of NBC, will speak to us. The afternoon will be spent at Channel 11's (WTTW) Public News Center, 2 Illinois Center, where we will hear from John Callaway, WTTW news commentator. Return to the Northwestern Station at approximately 3:30 p.m.

Tour Five Tuesday, Nov. 11 • Wednesday, Nov. 12

Bus departs at 9:00 a.m. for visits to three innovative public schools. The first two will illuminate the magnet approach to education, while the third will highlight a successful vocational work-study program. We will first tour the Walt Disney Magnet School, 4140 N. Marine Dr., an elementary school, where students are selected by computer to reflect the racial, cultural and ethnic composition of the district. The second visit will be to the new Whitney Young High School,

a city-wide magnet high school utilizing the open-space concept. Special learning facilities for the deaf will also be viewed. Following lunch at Jones Commercial High School, the third in the series, the group will observe business classes which may include courses in dress and grooming, skills training, and preparation for job interviews. Buses will return to Northwestern Station at approximately 3:30 p.m.

The tours are offered in four Field Trip Series: Series A (omits Tour 1); Series B (Omits Tour 3); Series C (Omits Tour 4); Series D (Omits Tour 5). The order blank for FIELD TRIP SERIES is printed at the bottom of this page. *It is important to show your preference with alternative choices:* A subscriber who lists first, second and third choices will have his order filled strictly in accordance with his preference, to the extent that tickets remain available. A subscriber who gives only one

choice will have his order returned if the series of his choice has been sold out. *It is also important to show whether the alternate date is acceptable if the weekday you prefer is sold out.*

Subscribers to the Speakers Program only, or to the Speakers Program and Single Tours (up to a maximum of three tours), please use the order blank printed on the reverse side. Either date may be chosen for each tour, but you should show whether the alternate date is acceptable.
