

THE JOURNEY HOME: OUR VETERANS RETURN

Those who have served our country have become invisible to most Americans, noticed only when they appear as casualties in a news story or as victims of our Veterans Administration system. We now have more veterans than at any time since World War II. Their homecoming is often complicated by physical, emotional, and financial challenges. Each service member's journey is unique. To honor and acknowledge them, this Tour will explore the issues veterans face as they transition from military to civilian life.

WE WILL:

Visit Edward Hines Veterans Hospital to learn how the VA healthcare system works.

See the VA's Prosthetics and Orthotics lab to discover how specialized prosthetics are custom-made and fitted on site for veterans, including the "power ankle."

Tour the Central Blind Rehabilitation Center, which helps sight-impaired veterans adapt to their new challenges.

Understand unique issues of female veterans, who face increased risk of joblessness and homelessness.

Listen to a panel of experts to better understand how service members are adapting leadership and technical skills developed in the military to the civilian workforce. Learn about the concept of "moral injury" and how veterans deal with the mental stresses of battle as they return to civilian life, including PTSD, military sexual trauma, depression, and addiction.

Talk with young veterans transitioning from military to civilian life, hear their stories, and learn how they support each other.

HOMELESS IN CHICAGO: NOT BY CHOICE

At least one-third of Americans are either one paycheck or one medical emergency away from homelessness. Someone is homeless if they lack permanent housing; they may live in shelters, on the street, or doubled up with others. Families make up the largest percentage of Chicagoans experiencing homelessness. Chicago Public Schools report that more than 17,000 of their students are homeless. Many homeless teens are completely on their own. A number of homeless adults work, but don't earn enough money to rent an apartment. Others cannot find adequate shelter and must remain on the streets.

JOIN US AS WE:

Meet individuals who have experienced homelessness. Some tent cities are efficiently managed by the residents as they hope for a permanent solution.

Tour a homeless shelter that provides emotional support and a safe place to sleep, and a clinic that offers medical, dental, and mental health care.

Learn about programs that provide job training and connections to employment opportunities, and supportive and affordable housing.

Discover the sense of community engendered by homeless citizens who share meals and camaraderie in spite of the hardships they face.

Hear how organizations like Heartland Alliance, Streetwise, the Salvation Army, and the Chicago Coalition for the Homeless advocate for permanent housing, employment, and dignity.

Join us to hear compelling stories and become more aware, empathetic, and able to help the homeless in Chicago.

REVERSING A REPUTATION: THE CHICAGO RIVER

The Chicago River has long complemented Lake Michigan as a treasured natural resource. Only recently, however, has the city begun transforming this industrial and shipping corridor into enticing public space. Learn about the vision and action agendas rebranding this water gem to lure businesses, investors, scientists, developers, adventurers, visionaries, and yes, ordinary Chicagoans too. Learn how multiple agencies are collaborating to strengthen opportunities along 155 miles of riverfront.

Explore the architectural model of a spectacular new residential highrise at the river's mouth. Be captivated by floor-to-ceiling murals offering 360 degree night and day shots. Hear about extraordinary construction challenges.

Enjoy show-stopping views of the Riverwalk, which aims to be a vibrant tourist destination rivaling Millennium Park, with restaurants, concert venues,

sport rentals, and floating gardens. See innovative solutions for providing pedestrian access from street level to water's edge.

Learn about collaborative efforts to clean the water, protect the environment, provide recreation, and move toward dynamic and sustainable economies while lunching at a riverfront venue with a panel of forward-looking private and public sector experts. Their unique perspectives will provide insight into the intricacies of harnessing competing needs for the benefit of all.

Discover artifacts arranged to inspire interest in Chicago's nautical history at the new Chicago Maritime Museum, nestled on the river's South Branch at historic Bubbly Creek. Explore through maps, models, and photographs the critical role the river has played as a conduit for transportation, westward expansion, and the rise of Chicago as a center for trade.

THEY'VE GOT YOUR BACK:

PLANNING FOR CATASTROPHES

Terrorists release deadly gas on the Red Line . . . hackers seize control of the grid, shutting down transportation and energy systems . . . another “once in a century” storm leaves a trail of destruction and chaos. Who do you call?

Argonne National Laboratory is ahead of the game. Nicknamed the “Doomsday Squad,” a team of scientists creates predictive models anticipating how any disaster may unfold. By analyzing the cascading series of infrastructure and societal failures that follow such events, the team develops ways to build resilience into the systems. Identifying vulnerabilities, it provides guidance for industry and governments to strengthen energy, transportation, telecommunications, and water systems.

The Cook County Emergency Operations Center implements many of these recommended strategies. Using state of the art technology, it monitors conditions across the county and stands ready to respond to crises large or small. Whether providing backup power to a nursing home or restoring order to a tornado-ravaged town, they aim to get a situation in hand within three hours of arriving.

See Argonne’s Mira supercomputer, one of the fastest in the world and view simulations revealing how one isolated failure could trigger cross-country disasters.

Learn how security and technology devices are “cracked” to identify vulnerabilities.

Hear how the Tokyo sarin attack in subways led to improved air circulation and evacuation systems.

Visit a command center with eyes and ears across our five county area.

View an array of “military-ready” vehicles designed to provide critical telecommunications, energy, rescue, and repair support wherever needed.

Overbeck has conducted bone-chilling tours of Loyola University's hidden crypt. Bound to be creepy fun, featuring everything "from the sublime to the ridiculous," you'll leave better educated on theology, psychology, anthropology, Catholicism, and the Jesuits . . . and spooked by tales Father Overbeck can't resist telling.

Quench your thirst at the new Empirical Brewery on Morse Avenue. A community-focused business with a passion for great beer, Empirical celebrates beer, food, and Chicago culture—experimenting with beer-infused dishes, creating vibrant beer and food pairings, and crafting unique beer cocktails. This is a tour to raise your spirits!

EASY ONLINE REGISTRATION

Register at knowyourchicago.org. Online registrations will be processed immediately and you will know instantly which Tours you are registered to attend.

REGISTER WITH A FRIEND

One of your friends may register you online or you may register one (or more) of your friends online.

REGISTER BY PHONE

We encourage online registration. If not possible, you may call 773.702.1727. You cannot register more than one person over the phone.

Symposium registration is required for Tour registration until September 6, or until the Symposium sells out, whichever happens first.

TRANSPORTATION

Buses are provided for both the Symposium and the Tours. [Participants board buses on the north curb of Adams between Clinton and Jefferson](#) and buses leave promptly at 8:30 a.m. Unless specified as an extended tour, buses return at 3:15 p.m.

For the Symposium, participants are urged to ride the bus since valet parking at the University is limited.

For the Tours, participants are required to board the bus downtown and remain with that bus throughout the day. At the end of the Tour, participants are free to return home on their own rather than returning to the Clinton Street drop-off site. Buses depart promptly at the time specified; Tours operate on tight schedules and bus departure cannot be delayed.
